FAQ

When and where is the Asia Summit 2020 in-person event?

The Asia Summit 2020 in-person event will be held on December 9, 2020 at the Sands Expo & Convention Center, Level 5 Grand Ballroom, Singapore.

What will the Asia Summit 2020 in-person event be like?

The Asia Summit 2020 in-person event will be a gathering of 150 attendees, divided across zones of 50 individuals. The agenda will include live panel sessions, as well as opportunities for networking.

Can I network with other attendees from my zone?

Yes, you are free to network with other attendees in your designated zone with a mask worn at all times.

Can I intermingle across different zones?

No, due to mandated safe distancing measures, you cannot change your zone or intermingle between zones during the event. However, you are still allowed to exchange business cards in passing briefly.

If you would like to meet someone from a different zone, please schedule a meeting separately in a private setting that is outside the conference venue.

What safety measures will be implemented at the Asia Summit 2020 in-person event?

- Safe Management Measures, including wearing a mask, temperature taking, and social distancing rules are compulsory and must be strictly adhered to at all times. Delegates must not intermingle between zones. Networking is only within your designated zone, in groups of no more than 5 persons. The venue will have designated ingress/egress zones and thermal scanning machines at every point of entry and exit. There will also be designated quarantine areas and ambulances on standby in the event of any positive cases.
- Antigen Rapid Testing is a fast and less invasive method of testing with little to no discomfort during the procedure. It will be available on-site, and will take around 15 minutes to produce a positive/negative result.
- TraceTogether All attendees will also be required to pick up a
 TraceTogether electronic token and/or have the App installed and
 activated during registration. The TraceTogether is a digital system which
 the Singaporean Government implemented to allow for better contact
 tracing in response to the COVID-19 pandemic.
